- i. Brenda: talked to USDA. They said they'll consider giving a USDA loan to a charter at the end of second year.
  - 1. Because we're less than 3 years old, we have to pay \$25K for a feasibility study.
    - a. Worth it because we need it in order to get a loan. If we don't we find out why.
    - b. Our only other option to get out of our loan is to wait five year and get a bond, which could cost, \$500k?
    - c. Cost of a USDA loan will cost around \$150K which will be built into the loan.
    - d. Our current loan balloons every year.
    - e. Next census will likely put us out of a rural area. Could affect our
      - Clint motions to authorize members of finance committee to explore USDA financing engaging a financial advisor to structure a deal for up to ½% for the finance amount however no fees shall be paid or final loan documents signed without final approval from Bonneville Academy governing board.
