1. Verbal Warning: A verbal reminder of the expected behavior and a discussion about the violation.
2. Written Warning: A written notice documenting the behavior and reminding the student of the expected conduct.
3. Parent/Guardian Meeting: A meeting involving parents or guardians to discuss the behavior, consequences, and strategies for improvement.
4. Behavioral Contract: A formal agreement outlining specific expectations and consequences if the behavior continues.
5. Loss of Privileges: Temporary loss of privileges such as participation in extracurricular activities, field trips, or other school privileges.
6. School Counseling: Referral to in-school counseling services when and where appropriate with parental permission
7. In-school Suspension: Temporary removal from regular classes while remaining on school grounds to complete assigned work and reflect on behavior.
8. Law Enforcement: Referral to law enforcement when and where warranted based on the nature or severity of the action(s).
9. Out-of-school Suspension: Temporary exclusion from attending school and school-related activities due to severe or repeated violations.
10. Expulsion: Permanent removal from Bonneville Academy due to severe or repeated violations that significantly disrupt the learning environment or endanger the safety of others.

Bonneville Academy administration, faculty, and staff may determine and implement appropriate consequences based on the circumstances of each incident, considering factors such as the student's age, developmental stage, previous conduct, and the impact of the behavior on others. Major discipline will be determined and implemented by Bonneville's administration. Our goal is to support students in learning from their mistakes, making positive choices, and ultimately contributing positively to our school community.
